1. Introductions

Council Chair Cheryl Baker welcomed the Council Members to the meeting.

2. Public Invited to Address the Council

No members of the public were present.

3. APPROVAL OF THE AGENDA

A Motion to approve the Agenda was moved by Jon Torkelson and seconded by Jessica Hudson. The Motion passed unanimously.

4. APPROVAL OF MINUTES - MAY 23, 2011 COUNCIL MEETING

A Motion to approve the minutes of the May 23, 2011 meeting was moved by Jessica Hudson and seconded by Linda Kaufmann. The Motion passed unanimously.

5. PERS Medical Insurance for Retirees Resolution

Ms. Baker explained that although the NSCLS Council had approved a resolution at its May 23, 2011 meeting, Ms. Milliron was notified that the language required by PERS has changed somewhat, and that a new resolution with the current required language needed approval. A Motion to approve

the resolution presented at today's meeting was moved by Jon Torkelson and seconded by Jessica Hudson. The Motion passed unanimously.

6. RESOLUTION OF INTENT TO TERMINATE PERS RETIREMENT CONTRACT

Ms. Baker explained that this action is needed to start the process for getting an actuarial study from PERS on the cost of "buying out" existing contracts; this process takes about one year, there is no cost to NSCLS to have the study done, and there is no obligation to proceed further once the study is done. A Motion to approve the resolution was moved by Linda Kaufmann and seconded by Victor Zazueta. The Motion passed unanimously.

7. ELECTION OF NSCLS CHAIR, VICE CHAIR AND REPRESENTATIVE AT LARGE TO NLS STEERING COMMITTEE

Ms. Baker listed the slate recommended by the Nominating Committee:

Chair, Jody Meza

Vice Chair, Jan Erickson

Representative at large to NLS Steering Committee, Jessica Hudson.

There were no other nominations. A Motion to approve the recommended slate was moved by Jon Torkelson and seconded by Elizabeth Kelley. The Motion passed unanimously.

8. ANNOUNCEMENTS

Jessica Hudson reported that the Tehama County Library is building a bookmobile from a 17' used 2001 diesel bus. She also reported that the Library is partnering with the Tehama County Department of Education in training school library staff, generating about \$10,000 in revenue for the Library.

Jon Torkelson reported that Siskiyou County Library is recruiting for a County Librarian, and he distributed recruitment information.

Victor Zazueta reported that Humboldt County Library will not have to cut any staff at this time because of savings due to two retirements.

Elizabeth Kelly reported that Shasta Libraries is being sued by both the Tea Party and the ACLU because of the Library's limited public forum policy for outside the Redding Library. She also reported that Shasta Libraries is migrating to a Polaris ILS, as all libraries operated by LSSI are doing.

Linda Kaufmann reported that Del Norte Library received \$13,000 from its Foundation and purchased public access computers with the funds.

Cheryl Baker reported that the Friends of the Modoc County Library's 7th Annual June Jamboree is scheduled for June 25th. The fundraising event will include train rides, barbecue lunch, live entertainment, cultural demonstrations, historical displays, book sale and silent auction, and a live auction. She distributed flyers to Council members from neighboring libraries.

9. ADJOURNMENT

A Motion to adjourn was moved by Jessica Hudson and seconded by Jon Torkelson. The Motion passed unanimously. There being no further business, the meeting was adjourned at 12:10 p.m.
